4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Effects are believed to be due to overloading of the normal respiratory clearance mechanisms caused by the extreme study conditions. Rats may be particularly susceptible to particle clearance overload, resulting in lung injury and tumors. No increases in tumors were observed in male or female mice exposed under the same conditions.

Mutagenicity
